Dear Training Provider,

The Sheriff's Office is accepting requests to become a CCW training provider for our agency. We will accept providers located in Stanislaus County, San Joaquin County, Merced County and Tuolumne County. As defined in California Penal Code Section § 26165, the course of training for issuance of a CCW license may be any course acceptable to the licensing authority.

Providers wishing to become a recognized approved provider need to submit to this office the following:

1. Copy of all current certificates/permits held, establishing that you are a certified firearms instructor (i.e.: P.O.S.T., USCCA, BSIS, NRA). Instructors must have relevant, valid, training certifications within the past 5 years. This information is required for every individual working with each approved provider.
2. Instructor Bio (PDF or Word Document). Include prior experience, list of certifications, courses you have instructed and any additional information that would be relevant to you. This information is required for every individual working with each approved provider.
3. Name and Address of range where training will be conducted.
4. All lesson plans, to include course outline for carrying concealed weapons- **Initial** (Minimum 8 hours of instruction)
5. All lesson plans, to include course outline for carrying concealed weapons – **Renewal** (Minimum 4 hours of instruction)
6. Copy of current business license and liability insurance

Incomplete and late proposals will not be considered. The final date for you to submit your packet will be **May 30, 2022- NO EXCEPTIONS**. This packet should be sent to the following address:

All submissions will be reviewed by the Sheriff or his designee. Instructors meeting the requirements and if selected to be on the list will be notified in writing and provided the required safety certificate for issuance.

If you are not selected, you will be notified in writing. This decision will be final and there is no appeal process.

As the licensing authority for the issuance of concealed carry weapons permits, the Stanislaus County Sheriff's Office is committed to ensuring the quality of training. Your course should emphasize **SAFETY, MORAL AND ETHICAL DECISION MAKING, FIREARM EDUCATION** and reiterate the importance and responsibility of being licensed to carry a firearm. It is the responsibility of the training provider to ensure any statutes referenced in the training material is current. Working together, we can assure the citizens of Stanislaus County are provided top quality firearms training.
