Deputy Sheriff Trainee
\$26.42 - \$32.12/hourly

While attending the POST Basic Academy the Deputy Sheriff Trainee will complete State mandated training requirements learning to fulfill the duties of a Deputy Sheriff.

Deputy Sheriff I
\$34.99 - \$42.54/hourly

Patrols assigned areas for the protection of life and property, serves warrants, makes arrests, assists in investigations of violations or offenses committed by or against juveniles, interrogates persons suspected of crimes, and appears in court as a witness or arresting officer.

Deputy Sheriff II
\$38.50 - \$46.80/hourly

Patrols assigned areas for the protection of life and property, serves warrants, makes arrests, assists in investigations of violations or offenses committed by or against juveniles, interrogates persons suspected of crimes, and appears in court as a witness or arresting officer. In addition, CIT, DUI 11550 & Basic Traffic Collision Investigation Training.

Sergeant
\$46.02 - \$55.94/hourly

Supervises and commands the work of deputies in an assigned division of the Sheriff's Department and includes evaluating and disciplining assigned personnel. Supervises the training of deputies in law enforcement techniques, use of equipment and small arms, and related areas. Performs backup support services to patrol personnel.

Lieutenant
\$47.68- \$71.52/hourly

Plans, assigns, and coordinates the activities of law enforcement and clerical personnel in the assigned division. Expected to apply mature judgment and sound administrative practices in the day-to-day function of the department. Must possess a thorough knowledge of criminal and civil law pertaining to the coroner and maintains effective relationships with department divisions, other agencies and the community.

Captain
\$61.19 - \$91.79/hourly

Manages one of the divisions of the Sheriff's Department. Must be able to apply mature judgment and make effective decisions and take responsible action. Supervises, directs, and reviews activities of law enforcement and clerical personnel, disciplines and makes recommendations in personnel matters, recommends policies and procedures, prepares and reviews reports, studies grants and acts for superiors in their absence.

Custodial - Adult Detention

Deputy Sheriff - Custodial

\$32.73 - \$39.78/hourly

Receives, books, searches, escorts inmates to and from court, hospitals, and other facilities, serves as a hospital guard, registers, controls, supervises, inspects sanitation and oversees the feeding of inmates, cares for, and releases inmates in the Jail and Public Safety Center facilities. Must have the ability to direct and instruct groups of inmates, have a tolerant attitude towards those confined, be able to respond to a wide variety of situations and exercise sound judgment.

Sergeant - Custodial

\$39.34 - \$47.83/hourly

Supervises the work of personnel and inmates assigned to the Jail and Public Safety Center and administers the inmate services program and monitors grant and contract compliance. Makes recommendations on hiring, disciplining and assigning staff and inmates, and prepares, investigates, evaluates and presents verbal and/or written reports

Lieutenant - Custodial

\$42.74 - \$64.10/hourly

Manages, plans, assigns, and coordinates the activities of the custodial personnel. Oversees the receipt, care, and release of prisoners and their belongings. Makes recommendations on training, assignments, and discipline of staff and inmates. Expected to apply mature judgment and sound administrative practices in coordinating the day-to-day functions of Adult Detention and have the ability to translate the knowledge of the organization into effective leadership and maintains effective relationships with departmental divisions, other agencies and the community.

Captain

\$61.19 - \$91.79/hourly

Manages the Adult Detention Division of the Sheriff's Department. Must be able to apply mature judgment and make effective decisions and take responsible action. Supervises, directs, and reviews activities of Adult Detention and clerical personnel, disciplines and makes recommendations in personnel matter, recommends policies and procedures, prepares and review reports, studies and grants and acts for superiors in their absence.
